NOTICE OF APPRENTICE APPLICANT TESTS & WORKBOOK TESTING

December 2009

The following locations have been established for testing in December. For these tests, a proctor will be prepared to administer apprentice applicant testing (ABLE), as well as ongoing testing for apprentices who have received their books (**workbook tests**).

FOR APPRENTICE APPLICANTS: Employers who wish to qualify new apprentice applicants must have them take the entrance exam (ABLE), please fax the names of the individuals you wish to have tested prior to the testing date - this is so the CAFSA office will know which company the applicant is being sent from and we can let you know if he/she passed or failed.

FOR CURRENT APPRENTICES WISHING TO TEST FOR SECTIONS IN THEIR CURRENT WORKBOOK: Apprentices are to advise the employer of the specific test number they wish to take this month. The employer has on file the corresponding test, which was separated from the workbook at the time the workbook was received. The employer seals the test and answer sheet in a manner which ensures the document cannot be opened, with the security seal and envelope provided. The employer gives the sealed test (or tests) to the employee the day before the test is administered. When the apprentice arrives at the test site, the proctor unseals the test(s) and gives them back to the apprentice to complete. Once completed, the apprentice hands the test in. The proctor mails the tests to the National AFSA office for grading.

If there is a retake test A CHECK FOR \$10.00 MADE TO AFSA MUST BE INCLUDED.
